Across the country, state and local police executives are grappling with the consequences of new federal immigration policies. This panel will provide an overview of how police agencies are responding to new policies that may affect their ability to engage with immigrants in their communities, and may negatively impact public safety goals. Presenters will discuss the reemergence of the Secure Communities initiative,

DHS's renewed push to enter into 287(g) agreements, state efforts to force compliance with immigration detainer requests (e.g., Texas SB4) and potential consequences of such legislation, and the federal government's efforts to impose sanctions on so-called "Sanctuary Cities." Panel participants will focus on strategies to continue building trust, particularly for immigrant crime victims and witnesses, and will discuss current efforts to negate the impact of state and federal legislation that hinders trust-building.

Panelists will discuss accountability practices and strategies to improve the response of police and prosecutors to sexual assault cases. Topics will include case attrition, police-prosecutor collaborations, working with victim service providers, and accountability measures for ensuring your department is accurately accepting and coding sexual assault reports. Panelists will offer practical recommendations to address these challenges, derived from experience in the field, research, and case studies. Additional focus areas for the discussion: preventing bias; and ensuring that victim-centered and trauma-informed policies and practices are in place throughout the justice process.

It can be difficult for police agencies to keep up with the rapidly-evolving technological advancements, legal standards, and policy implications associated with body-worn cameras (BWCs). With more police agencies adopting this technology, and more research being done to evaluate the impacts of BWCs, we are gaining a better

understanding of how to effectively implement BWCs in a way that promotes accountability, transparency, and strong police-community relationships.

This panel will feature a discussion of PERF's recent research in Arlington, Texas, which examined the relationship between BWCs and community perceptions of police. The panel will also feature representatives from police agencies that have received grants as part of the Bureau of Justice Assistance (BJA) Body-Worn Camera Policy and Implementation Program. These agencies have developed comprehensive BWC programs that serve as examples to other agencies, and have demonstrated positive outcomes in term of improved case outcomes, reductions in citizen complaints, and reductions in use-of-force incidents.
